



# YOUR VOTING RIGHTS IN NEVADA Election Day: Tuesday, November 3, 2020

#### Who can vote?

- In order to vote in the election on November 3, you must be registered to vote. To register to vote:
  - You must have lived in Nevada for 30 days, be a U.S. citizen, and be age 18 or older on Election Day;
  - You must not be serving a sentence (including probation or parole) for a felony conviction.
- If you are not already registered to vote, you can register online by Oct. 29.
- You can also register to vote in person on Election Day at a polling place. If you register to vote on Election Day, you must present a Nevada DMV-issued identification card that shows your current physical address. If the NV driver's license or ID card does not have your current address, you must show a government document, utility bill, or paycheck that shows your name and current residential address. You will be able to cast a provisional ballot.

Can I vote by mail?

- All active registered voters will be sent a ballot in the mail, but voters can choose to vote in person instead if they want to.

- How to vote your mail ballot:
  - Mail it to your county using the provided postage prepaid ballot return envelope, **postmarked by November 3**.
  - Turn it in yourself at a ballot drop-off location. Ballots returned at a drop-off location must be dropped off prior to 7:00 pm on November 3.

## How do I vote in person?

- Early voting begins on Saturday, October 17 and runs through Friday, October 30.

- **On Election Day,** vote at your polling place.
- **ID**? In most cases, Nevada voters are not required to show identification (ID) at their polling place. You only need to show one of the following IDs listed on this page under "I.D. Requirements at the Polls" if your name does not appear in the register to vote: <u>https://www.nvsos.gov/sos/sos-information/office-facts/faqs-all-division/elections</u>. If you are voting for the first time and you registered by mail and did not include ID, you have to show ID when you vote.

## Can I bring someone to help me vote?

- Yes. If you need help reading in English or help voting, you can bring a person into the voting booth to help you vote. You can bring any person except your employer, an agent of your employer, your union representative, or a candidate running in the election. The person you bring does not need to be a registered voter.
- In Clark County, you are entitled to a Spanish language ballot and assistance in Spanish.

#### What if my name is not on the list of voters?

• If your name is not on the list, or there is a problem with your ID, you have the right to vote on a provisional ballot. Be sure to ask for a provisional ballot if there is a problem at the polling place.
