



YOUR VOTING RIGHTS IN NEVADA Election Day: Tuesday, November 5, 2024

Who can vote?

- In order to vote in the election on November 5, you must be registered to vote. To register to vote:
 - You must have lived in Nevada for 30 days and your precinct for 10 days prior to Election Day, be a U.S. citizen, and be age 18 or older on Election Day;
 - O You must not be serving a sentence for a felony conviction.
 - O You must not have been declared mentally incompetent by a court of law.
- If you are not already registered to vote, you can register online by October 23.
- You can also register to vote in person on Election Day at a polling place. If you register to vote on Election Day, you must present a Nevada DMV-issued identification card that shows your current physical address. If the NV driver's license or ID card does not have your current address, you must show a government document, utility bill, or paycheck that shows your name and current residential address. If you register to vote on Election Day, you will be allowed to cast a provisional ballot.

Can I vote by mail?

- All active registered voters will be sent a ballot in the mail but can choose to vote in person instead. Nevada will begin sending out ballots to actively registered voters between October 16-22. If you register to vote after October 22, you may only vote in-person.

- How to vote your mail ballot:
 - Mail it to your county using the provided postage prepaid ballot return envelope, postmarked by November 5.
 - Turn it in yourself at a ballot drop-off location. Ballots returned at a drop-off location must be dropped off prior to 7:00 pm on November 5.

How do I vote in person?

- Early voting begins on Saturday, October 19 and runs through Friday, November 1.

- On Election Day, Clark and Washoe County voters may vote at any vote center. Check with your county official for voting location information.
- **ID?** In most cases, Nevada voters are not required to show identification (ID) at their polling place. If you are doing same-day registration, you **must** have a valid Nevada driver's license or Nevada ID card and you **must** vote in-person at a polling location.

Can I bring someone to help me vote?

- Yes. If you need help reading in English or help voting, you can bring a person into the voting booth to help you vote. You can bring any person except your employer, an agent of your employer, your union representative, or a candidate running in the election. The person you bring does not need to be a registered voter.
- In Clark County, you are entitled to a Spanish language ballot and assistance in Spanish.

What if my name is not on the list of voters?

• If your name is not on the list, or there is a problem with your ID, you have the right to vote on a provisional ballot.
